



**THE SEAWAY INTERNATIONAL BRIDGE CORPORATION, LTD.
2021-2022 ANNUAL REPORT TO PARLIAMENT ON
THE ACCESS TO INFORMATION ACT**

1. INTRODUCTION

The *Access to Information Act* provides a right of access to information in records under the control of government institutions. In accordance with the principles that government information should be available to the public, that necessary exceptions to the right of access should be limited and specific, and that decisions on the disclosure of government information should be reviewed independently of government.

The 2021-2022 Annual Report to Parliament of The Seaway International Bridge Corporation, Ltd. (SIBC) is prepared and tabled in Parliament in accordance with section 94 of the *Access to Information Act*.

The SIBC was established in 1962 under the *Canada Corporations Act*, and continued in 1980 under the *Canada Business Corporations Act*. It manages and operates the international crossing between Cornwall, Ontario and Rooseveltown, New York. That includes the North Channel Bridge located in Canada and owned by The Federal Bridge Corporation Limited (FBCL), the South Channel Bridge which spans the international border with the Canadian portion (32%) owned by The Federal Bridge Corporation Limited (FBCL) and the remainder by its U.S counterpart, as well as a land corridor across Cornwall Island.

2. ORGANIZATIONAL STRUCTURE

The SIBC is a wholly owned subsidiary of FBCL. The Chief Corporate Services Officer of the FBCL has discharged the Corporation's *Access to Information Act* responsibilities during 2021-2022. FBCL's Manager of Information Management supported him in this function.

3. DELEGATION ORDER

The Bridge Director of the SIBC delegated his powers and responsibilities under the *Access to Information Act* to the Chief Corporate Services Officer of the FBCL.

A copy of the Delegation Order is attached as Annex A.

4. PERFORMANCE

For the 2021-2022 reporting period, SIBC did not received any request under the *Access to Information Act*.

At the beginning of this reporting period, SIBC had no active requests outstanding from previous reporting periods.

At the beginning of this reporting period, SIBC had no active complaints outstanding from previous reporting periods.

SIBC did not received any consultation request from other Government of Canada institutions.

Measures taken in relation with COVID-19 have not affected SIBC ability to fulfill its *Access to Information Act* responsibilities.

2021-2022 STATISTICAL REPORT PURSUANT TO THE *ACCESS TO INFORMATION ACT*

The annual Statistical Report of The Seaway International Bridge Corporation, Ltd. (SIBC) completed under the *Access to Information Act* indicates that no request was submitted to SIBC under the legislation during fiscal year 2021-2022.

The SIBC did not processed any consultation request from other Government of Canada institutions.

Supplemental Statistical Report on the *Access to Information Act* and *Privacy Act* submitted by The Seaway International Bridge Corporation, Ltd. shows that SIBC was able to receive and process ATIP requests throughout the year.

The SIBC manages and operates an international crossing linking Cornwall, Ontario and Rooseveltown, New York. Questions raised by the users of the facility are promptly answered by staff on duty twenty-four hours a day. The Corporation also has a well-used website.

It is to be noted that SIBC is a wholly owned subsidiary of The Federal Bridge Corporation Limited (FBCL). FBCL administers SIBC's *Access to Information Act* program.
